What Do We Do?

Background

The Charity was founded on the 19th November 2003, specifically to help children and young people with physical disabilities, in Stourbridge and the surrounding areas, which for practical reasons we defined as being within a 50 mile radius of Stourbridge. The Charity Commission registered number is 1101230. The stated aim is: *"The provision of financial assistance, at the discretion of the Trustees, to provide the relief of physically handicapped children. This includes improvement to the quality of life by the provision of financial or other assistance, or any other purpose the Trustees deem to be in accordance with the stated aim".*

How we can help

We can provide the funding, or balance of funding, required for the purchase of mobility/sensory/vision equipment when the NHS Trusts/Families are unable to provide support. We aim to respond within 24 to 48 hours as we consider a rapid response is essential when children have degenerative or life limiting conditions. We operate with zero administration costs so that every penny donated goes to help those the donor intended to support. Typically we fund:

- Special exercise equipment, special exercise tricycles, walkers, and standing frames, to assist in regaining and maintaining mobility
- Wheelchairs, special mobility chairs, special car seats and safety harnesses, special seating, special beds, support and lifting equipment, vision equipment and sensory room equipment, to improve the quality of life.

How we assess Grant Applications

Following an initial approach, we request the submission of a detailed grant application. In order to assess the position, we typically require the following:

- Background and reason for the request
- Supporting information from a suitable professional person detailing the medical position and the advantages of the proposed equipment purchase
- A detailed quotation, following assessment by the supplier's competent person
- Details of any funding already raised, any other sources of funding, and the financial position of the family

Provided that we are assured that our help will be for those in real need, the application is in accordance with our grant criteria, and we have the funding available, it will be considered for approval. Grants are funded either by a cheque or online payment to the supplier, to ensure that the funds are only used for the intended purpose. All remaining order and delivery arrangements are then left to the applicant, so that we are not involved in any administration costs.

What have we been up to in 2018?

Another Busy Year:

We completed a further 88 grants totalling £109,438.01 during the year, bringing the total grants since inception in November 2003 to 600, and £736,120 granted, closing in on our next milestone of £750,000 raised and granted. We have completed this work with zero administration costs so that every penny donated, together with Gift Aid, where we could claim it, has been used for the benefit of the children in need.

Fundraising Events and Collections:

We have attached a few reports on fundraising events, but throughout the year we have been helped by a number of different groups, with the cumulative effect being substantial. In particular we would like to thank several large personal donors, as well as: Alloy Wire International, Paul Matty Sportscars, Miller Roofing, Hagley Seniors Golf, Kinver Floral Arts, Old Halesownians Masonic Lodge, Butterfly Fellowship 2012, The Netherton Methodist Wives Club, The Ellenvale Singers, St Thomas's Church Christmas Tree Festival Committee, The Pedmore Men's Club, Harris Steels, Graham Godfrey Consultancy, Stourbridge Golf Club (where we are one of the Captain's charities for 2018 and 2019), and Stourbridge Tennis Club (*with apologies for any group missed out by the Editor*). An uncle of a child we had previously helped ran in the Edinburgh Marathon and collected £3,010.00 for us, and we were also helped by our regular donors, various collection boxes, three funeral collections, and support from a number of Charitable Foundations.

Trying to raise over £100,000/year does present a real challenge, and we greatly welcome any and all donations. We are awaiting the results of one collection, from a Christmas event, but we ended the year close to our target of raising at least £100,000. With expenditure slightly ahead of that, we have again drawn on our reserves, as it is our policy to use our reserves for the purpose for which they were donated, rather than just retain them as a Bank balance. As usual, we shall attempt to raise further funding in 2019 to try to cope with the requests for help that we receive, and hopefully rebuild our reserves a little, by the year end.

We hope to receive a further boost to funds early in the New Year, but if demand continues to increase we may reach a point where the limits of our fundraising ability impact on the help we can give. The New Year will present the usual massive challenge, but with the assistance of our supporters, we hope that we will once again be able to respond to it.

Why is our charitable funding needed?

While various State systems will provide a number of items of equipment for disabled children, with the inevitable funding constraints there are restrictions on the extent of help available, and with seemingly ever increasing demands on the system, the rules regarding what will be supplied are constantly tightening. The resultant unfunded needs lead to requests for help, either directly from families, or via relevant professionals such as the Paediatric/Occupational Therapists working in the Children with Special Needs Departments of the local NHS Trusts, and from the Special Schools where constant tightening of budgets has led to further requests for help.

Typically, the equipment funded falls into these general categories:

- **Exercise:** Specifically to develop the necessary muscles and coordination to either improve independence in daily activities, or to slow a deterioration in current mobility. Typical equipment funded includes special exercise trikes, walkers, standing frames etc.
- **Special Seating:** For school or home use, to provide the correct postural support, and enable a child to participate in activities in either location.
- **Comfort:** Many of the cases helped involve severe mobility problems, often wheelchair bound, with the need to periodically change position, provide the correct postural support, and relieve pressure points. Equipment funded includes special comfortable support chairs, Acheeva beds, and special support seating systems.
- *Health and safety:* Special car seats to provide the support a child may need, and to hold them securely, as certain children would otherwise release themselves from their car seat and endanger driver safety. Also, any form of equipment specifically to hold a child safely and provide the correct postural support, as well as hoists and equipment to help with daily living needs.
- **Sensory:** We receive a number of requests for equipment to help to calm and control a range of behavioural problems, and provide quiet and safe areas.
- **Sleep:** requests usually involve either equipment specifically to hold a child in the correct position to avoid hip dislocations, and all types of special beds eg. profile beds, high sided cot beds and safety sleepers to provide the correct environment for sleep.
- **Vision:** All types of vision equipment to help registered blind children achieve their potential when the Vision Impairment Service is unable to obtain the necessary funding for the equipment required.



How a Donation Can Help (1)

Special car Seats.....

Abel was 14 months old with a diagnosis of Benign External Hydrocephalus, possibly as a result of contracting sepsis after birth. He struggled with head control, particularly when tired, and the family was advised that a more reclined special car seat, with additional head support, would help, as he tended to slump forwards. This gave problems with his breathing, and a full assessment was carried out.

A Radian 5 special car seat was proposed at a cost £391.35, which was reduced to £369.23 by our discount agreement with the supplier. Abel can be seen in his car seat, now securely held for safe and comfortable transport.

Special Exercise Trikes......

Emilio had a brain injury at birth, which presents as difficult to control epilepsy, mild right sided hemiplegia, visual impairment, hypermobility, and processing difficulties.

The request was for help with funding the purchase of a special exercise trike to help to build leg strength, and improve his coordination. With the family able to raise ± 300.00 towards the cost, we agreed to fund the balance required of $\pm 1,036.50$.

Emilio has had a further recent spell in hospital, and the photograph shows him now starting to use the trike, which we hope will further help his recovery.

How a Donation Can Help (2)

Standing Frames.....

Amelia has a diagnosis of Cerebral Palsy Dystonic and Dyskinetic. Unable to support herself independently in a standing position, she was already showing signs of deterioration from lack of weight bearing. We were asked if we could help with the funding for a combined prone and supine stander for home use, similar to the one she was using at her special school. In view of the urgent need we agreed to fund the cost of £2,104.00, and it was quickly put into use by the family.



Special Support Chairs......

James was born prematurely and has had a range of medical problems, including sepsis, and a bowel obstruction. Unable to stand independently, we were asked if we could help with funding the purchase of a Birillo Child's Wheeled Walker, to improve his sitting position and help to strengthen his trunk and lower limbs, with the aim of getting him to start walking. The cost was £579.95, and his family reports that he loves using it, so we are hopeful of further progress in the near future.







Details of a few more of the Grants Made in 2018


Age (Yrs)	Grant (£)	Details
18	2,113.75	Duchenne Muscular Dystrophy and full time wheelchair user. He is fully dependent on his carers for all transfers, and needs a fully supportive chair to help with relieving pressure points, and capable of holding him correctly. Currently he has nowhere suitable to sit, and he needs to be held correctly when sitting, so agreed to fully fund.
4	3,820.00	She has a diagnosis of a chromosomal abnormality, Trisomy 9 Mosaic, and partial Trisomy 11 Mosaic. She exhibits complex medical problems, physical and learning disabilities, and is a full time wheelchair user. She was using a special cot bed, on loan from another charity, and needing to be returned. She requires constant monitoring and oxygen during the night, and the bed has proved to help the family greatly. We agreed to provide the balance of funding needed.
3.5	355.00	Rett Syndrome, which affects brain development and results in learning and mobility difficulties. She is non-mobile, and unable to sit with the correct posture. The requirement was for a portable posture support seat for her, which we agreed to fully fund.
8	1,200.00	He has a diagnosis of Sickle Cell Anaemia, with duplication of two chromosomes, and also exhibits global development delay. He suffers with leg pain, has regular physiotherapy, and his Paediatric Physiotherapist recommended a special exercise trike to try to build his leg muscle strength and improve his mobility. We agreed to fund the balance required for the purchase.
2	1006.98	He has a diagnosis of Periventricular Leukomalacia (a form of damage to part of the white matter of the brain) which exhibits as motor and development problems. He is still struggling to walk and with spasticity in his legs, his Paediatric Physiotherapist recommended a special exercise trike to help him to develop. We agreed to fund the balance of funding required for the purchase to proceed.
18	1,946.55	He has a diagnosis of Adrenal Leukodystrophy, and exhibits early onset dementia. He is rapidly losing mobility, is a wheelchair user, and requires a hoist for all transfers. His local NHS Trust will not fund a comfortable chair to hold him in the correct position, so we agreed to fund the full cost of a Hydro tilt chair for him.
9	1,408.75	Born with Gastroscesis (a condition where the baby's intestines and sometimes other organs are outside the body at birth) and has undergone multiple operations. He did not walk until 2.5 years and exhibits muscle weakness. This is now causing more problems, and it was proposed to provide him with a special exercise trike, to help to build core strength. We agreed to fully fund the purchase.

After the exceptional levels of activity in 2016 and 2017, we were concerned about our funding for 2018. We were relieved to see activity slow a little to 88 grants totalling £109,438.01, although once again timing was an issue, as we were aware of several applications in preparation.

Once again we found that approx 50% of our grants by number were for less than £1,000.00, but only required 22% of the total granted. This shows how small targeted grants can often make a major difference to families needing help.

The Organisation

We continue to run the organisation with four Trustees, who cover all the work necessary, and contribute any minor incidental expenses incurred, so that the Charity can operate with zero administration costs.

We are all in regular email and telephone contact, which, as a small group, enables us to give a fast response to grant application requests that are in accordance with our grant criteria. We hold two formal meetings a year, where we complete a full six monthly review of the organisation, and we quickly assemble for any additional meetings, as necessary.

It is our intention to continue to operate with zero administration costs, and a fast response, to meet the needs of those who apply to us for help, and the expectations of those who so kindly contribute and support us. The only concern on our horizon is ensuring that we can raise adequate funding, which with the rapid growth we have seen in demand, constantly puts our reserves under pressure. This is a problem we continually face, and we hope that with sufficient help and support we shall again be able to complete our work in 2019.

Gift Aid

If you are a UK tax payer, you can increase the effectiveness of your donation by completion of a gift aid declaration form, a copy of which is available at the end of this brochure. If the third box down, of the three options on the form, is ticked, the completion of one form will cover all donations past, present and future. Provided that you are a UK tax payer, the Charity will receive an additional 25p for every £1 donated, which we claim annually from HMRC.

How Donations can be made to us (2)

Commission payments from Retailers through Give as You Live, when purchases are made online or in-store.

Give as You Live is part of the *Everyclick Group* and the Charity is registered to receive commission payments whenever purchases are made through the *Give as You Live* portal, from a wide range of major store groups.

There are two systems that can be used, and each one returns a commission to the Charity typically between 0.5% and 3% of the purchase cost. There are no additional costs, and the user, having registered, shops in the normal way. The Charity then benefits from the commission payments.

The main menu button labelled "Give as You Live" on the Charity website homepage (<u>www.chriswestwoodcharity.co.uk</u>) will take you to a webpage explaining how the system works, and how you can help us.

There are two methods of helping the Charity through Give as You Live:

- You can set up a shopping homepage for your favourite online stores. Once you have registered and selected the Charity as the recipient (you only need to type "Chris Westwood Charity" into the Search box), you can enter the store website with just a couple of clicks. You can then proceed with any desired purchases in the normal way, including payment. By using this entry route through Give as You Live, the Charity will receive a commission payment, typically between 0.5% and 3%. There are no additional costs involved, and the Charity benefits every time you purchase. You can register with as many store groups as you wish.
- You can also register for an in-store reloadable store card for a specific store group (typically where you do the bulk of the weekly shop). Every time you top up the card with additional funding (online using your Debit card), the Charity receives the commission payment. You shop in the normal way and instead of paying by Debit/Credit card at the checkout, you use the reloadable card. Apart from an initial fee of £2.50 for a reloadable card for your chosen store group, once set up, there are no other costs and the Charity benefits every time the card is topped up, at no additional cost to you.

While we would hope that you might consider using this commission based system to raise funds for the Charity, you can change your selected charity at anytime, so this method is still worth considering to help whichever cause you might wish to support.
